

Addendum to Article 20.5 Outline SBE Economics pre-masters of the BSc EER 2022-2023 for the course Information, Markets and Organisations (EBC2108)

Article 1 Applicability

1. This addendum is applicable to students studying in the following pre-master programmes in the academic year 2022-2023: Pre-master Economics and Pre-master Human Decision Science.
2. This addendum is applicable to students who, according to their regular study outline, should complete the course *Information, Market and Organisations* (EBC2108) in the fifth period of the academic year 2022-2023 as laid down in Article 20.5 of the BSc EER 2022-2023, and provides these students with the possibility to follow an alternative course in period 5 of the academic year 2022-2023.

Article 2 Alternative course to fulfil the pre-master exam requirements for students that fall under Article 1

Students are allowed to choose the following course in period 5 of academic year 2022-2023: *Intermediate Microeconomics for Pre-master* (EBC2197) instead of the course *Information, Market and Organisations* (EBC2108). The pre-masters Economics and Human Decision Science will have the following course outlines:

Article 3 Unsuccessful completion of the alternative course

1. Students who started their pre-master programme in the academic year 2022-2023 for the first time and who choose but failed the first and second sit of one of the courses (EBC2197 or EBC2108) in the fifth period of academic year 2022-2023, can repeat the course (EBC2108 or EBC2197) in period 5 of academic year 2023-2024.
2. Students who have not been able to complete course EBC2197 or EBC2108 in the academic year 2023-2024 do not comply with the requirement to successfully complete the pre-master in two academic years as per Article 20.6 paragraph 4 of the SBE BSc-EER 2022-2023.

Article 4 Transitional regulations for repeat students

1. Students who followed Information, Market and Organisations (EBC2108) for the first time in the fifth period of academic year 2021-2022 and who have not successfully completed the course, can:
 - repeat EBC2108 in the fifth period of academic year 2022-2023 or;
 - replace EBC2108 with the alternative course Intermediate Microeconomics for Pre-master (EBC2197).
2. Students who followed Information, Market and Organisations (EBC2108) for the first time in the fifth period of the academic year 2021-2022 and who have not been able to complete EBC2108 or EBC2197 in academic year 2022-2023 do not comply with the requirement to successfully complete the pre-master in two academic years as per Article 20.6 paragraph 4 of the SBE BSc-EER 2022-2023.
