

# **Openbaar Ministerie**

The Openbaar Ministerie (Public Prosecution Service) is responsible for investigating and prosecuting criminal offences on behalf of society at large. Its work aims at ensuring that those who commit crimes are punished appropriately, that victims and next of kin feel that someone is on their side, and that the Dutch public are confident that the law of the Netherlands are applied fairly and correctly.

These are the main tasks of the OM:

- Preside over the police to detect criminal offences
- Prosecute criminal offences and bringing suspects to justice
- Prosecute criminal offences without intervention by the court

The OM is a national organization devided over ten districts. These are equal to the ten regional police units.

Common crimes such as (petty) theft, vandalism, violence around bars or embezzlement cause a lot of trouble and requires decisive and balanced action. The OM looks after the investigation and prosecution of these criminal offences by collaborating the police and other investigative agencies at the so-called ZSM-locations (ZSM stands for 'Zorgvuldig, Snel en op Maat'; diligent, quick and tailor-made). At these ZMS-locations, the district attorney can decide quickly over the case. The district attorney takes into account the advice of the organisation within the ZSM-network, the interests of the victims, the offenders and the society. In this workshop, we will discuss a number of cases that are treated by the ZSM.
