MORSE wants to work towards also establishing itself as a physical research and teaching infrastructure at SBE. The idea that we will be exploring in the next months is to create the **MORSE social sciences simulation lab**, where serious gaming and scenario simulations will be developed as tools for immersive learning in education and post-graduate education and training, but also as a research tool. In the new lab, we can play out slow onset and sudden shocks in realistic scenarios for (future) business, political and academic leaders. Modern ICT technologies and developments in (serious) gaming allow Maastricht University to start experimenting with these new

educational tools and MORSE will gladly take the lead in developing this for the urgent challenges that our society faces. It will make MORSE a place in addition to a network.

This project is still very much in the exploration stage, but if you are interested and enthusiastic about joining us, please reach out to m.sanders@maastrichtuniversity.nl to indicate your interest and relevant expertise. We will organize a first brainstorming session to plan a course, divide tasks and collect ideas in May 2023. We aim to develop this into a proposal (chat GPT wrote an interesting first draft you could find here) to the SBE and UM board by the end of 2023.

Erasmus+ ECOffee Project on Sustainable Coffee Consumption

The ECOffee project is a two-year ERASMUS+ project that aims to develop innovative educational methods to promote sustainable consumption habits to adults, particularly producers and consumers in the coffee industry. The project's goal is to trigger a transformative, systemic change in consumption habits by utilizing existing and developing new tools and methods based on the principles of Technology Enhanced Learning. The project will result in a sustainable cafeteria cluster, video tutorials for consumers, an e-guidebook for cafeteria owners and trainers, and a smartphone application for sustainable and eco-friendly coffee consumption habits.
