## Admission requirements

On this page, you will find important details of the application process (such as deadlines, admission requirements, required documents and application assessment) for the master's programme in Forensics, Criminology and Law for the *academic year 2023-2024*.

## Important deadlines for this study programme

*The master's programme in Forensics, Criminology and Law starts in September.  
 The deadlines below are applicable for applying for a start in September 2023.*

When you want to apply or are applying for this study programme, it is important that you inform yourself of the deadlines that you need to meet. The important deadlines when applying for this study programme are provided in the table below.

<b>Up to and including 1 June 2023, 23:59 CET</b>	Deadline for completing the entire application process for <b>EU/EEA</b> applicants

## General requirements: previous education

The admission requirements for academic year 2023/24 for the master's programme Forensics, Criminology and Law depend on your previous education. Please check below which requirements apply to you.

## Graduates from a Dutch or Belgian university bachelor's or master's programme in Criminology

You qualify for admission to the master's programme Forensics, Criminology and Law. No extra requirements apply to you.

## Graduates from an acknowledged university bachelor's or master's programme in Law

You qualify for admission to the master's programme Forensics, Criminology and Law if you have a university bachelor's degree in Law. Most European academic law programmes give direct access to the master FCL, as well as a number of non-European Law programmes. The master coordinator has a final say in relation to the eligibility. An Introductory course in criminology, psychology and law, forensic psychiatry or forensic psychology is recommended.

## Graduates from other university bachelor's or master's programmes

If you have another educational background, it is up to the master coordinator to decide whether your academic background is suitable, and your motivation sufficient, for participation in the master FCL. If so, you will be invited to do an entrance-exam. You'll have to pass this exam to get access to the master programme.

## The entrance exam will be discontinued and offered for the last time in March 2023

If you do not pass the entrance exam in January 2023, you can take it **for the last time** in March 2023, there will be no possibility to take a resit. Does your previous education not qualify for direct admission to a master's programme in Law? Then you can apply for the [Pre-master Law](#) that will start from **September 2023**.

## Pre-master Law

Does your bachelor's degree not qualify for direct admission to a master's programme in Law? Then you can apply for the pre-master Law. This is a preparation programme for students with a HBO (University of Applied Science) or University bachelor's degree who want to pursue a university master's degree at the UM Faculty of Law but are not eligible for direct admission to our English taught programmes.

All candidates are required to submit a language certificate (IELTS, TOEFL, or Cambridge) in order to prove their proficiency in academic English, except when they have previously completed a study programme in this language or have obtained a sufficient number of ECTS in English-taught courses.

### ***Required documents for all applicants to this study programme***

#### **A recent portrait picture**

*This picture must satisfy certain [requirements](#).*

#### **A copy of your valid passport or your EU/EEA identity card**

*Make a copy of the page with your personal details. Save this copy as 'passport copy' and not as 'passport picture'.*

#### **A copy of your most recent certified grades transcript and a copy of your certified diploma if you have obtained it. If you have not graduated yet, you can upload your official grades transcript from your bachelor's programme**

- **Letter of motivation**

*All candidates must write a well-prepared and structured letter of motivation for this specific master's programme. The letter should explain your motivation for choosing this specific Master's programme. It should also include an overview of what you intend to learn and how this programme fits into your future professional plans. The letter must be dated and addressed to the Board of Admissions of the Faculty of Law.*

- **Demonstrate your Proficiency in English**

*All candidates are required to submit a language certificate (IELTS, TOEFL, or Cambridge) in order to prove their proficiency in academic English, except when they have previously completed a study programme in this language or have obtained a sufficient number of ECTS in English-taught courses.*

**Please note:** Only complete registrations will be taken into consideration. All documents must be in Dutch, English or German.
